Points and Places: Statewide- New Mexico

Pursuant to New Mexico Public Regulation Commission 18.3.6 NMSA 1978, 65-2A and 21. Blue Sky Logistics, Inc DBA MedConnect is hereby submitting its proposed tariff as required. This tariff governs rates for statewide, non-emergency medical transport services per Medicaid Transportation Policy for covered services and service limitations. Vehicles will be used to transport clients only. The physician must attest to the need for an attendant in writing. Mileage can only be calculated and documented when client is within the vehicle. Modifiers identify origin and destination transport.

General Provisions:
