SCOPE:

Pursuant to New Mexico Public Regulation Commission 18.3.6 NMSA 1978, 65-2A and 21, Family Faith Medical Transport, LLC is hereby submitting its proposed Tariff as required. This Tariff governs rates for statewide, non-emergency medical transport services per Medicaid Transportation Policy for covered services and service limitations. Vehicles will be used to transport clients only. The physician must attest to the need for an attendant in writing. Mileage can only be calculated and documented when client is within the vehicle. Modifiers identify origin and destination of transport.

ALL RULES AND REGULATIONS THAT GOVERN NON-EMERGENCY MEDICAL TRANSPORT SERVICES IN THE
STATE OF NEW MEXICO ARE CONTAINED IN THE PUBLIC REGULATION COMMISSION MOTOR
TRANSPORTATION RULES.

Distance rates are based on the distance from point of origin to final destination, computed in accordance with New Mexico Medicaid Reimbursement Transportation Policy as listed below:

Non-Emergency Transport Service mile	\$1.68/Mile - \$230 Limit paid per 1-way trip; unit = 1
Non-Emergency Transport Service w/c van mile	\$1.68/ Mile - \$230 Limit paid per 1-way trip; unit = 1
Physician approved family member	\$168/Mile - \$230 Limit paid per 1-way trip; unit = 1 mile
Physician approved 2-4 family member	.58/Mile - \$115 Limit paid per 1-way trip; unit = 1 mile
Physician approved Attendant/Escort	.58/Mile - \$115 Limit paid per 1-way trip; unit = 1 mile

GENERAL PROVISIONS:

- Family Faith Medical Transport, LLC will endeavor to maintain schedules, but not be liable for delays caused by unforeseen circumstances beyond our control, such as weather conditions, icy/muddy roads or roadside accident and/or closures.
- Family Faith Medical Transport, LLC will not be responsible for damaged, lost or stolen items.
- FFMT, LLC will not transport animals, service dogs accompanying patients will be accepted.
- Family Faith Medical Transport, LLC reserves the right to refuse to transport a person or persons under the influence of intoxicating liquor or drugs, or who is incapable of taking care of himself or herself, or who shows conduct which is such, or is likely to be such, as to make him or her objectionable to drivers or passengers. The above rule does not apply to an ill person accompanied by an attendant or a care provider.
