TERRITORY:

All of Eileen Acres Subdivision and contiguous unplatted lands owned by Eileen Acres Service Corporation which may be added to Eileen Acres Subdivision and certain additional contiguous lands, to which sewer services are now being and may be furnished by Eileen Acres Service Corporation.

MONTHLY RATE:



TAX ADJUSTMENT:

Billings under this rate may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state, and federal income taxes) payable by the utility and levied or assessed by any governmental authority on the public utility service rendered, or on the right or privilege of rendering the service, or on any object or event incidental to the rendition of the service.

LIMITATION:

Sewer furnished under the Residential Sewer Service Rate shall be furnished to any improved residential unit site, a commercial customer and any unit site for which residential improvements have been authorized by a building permit issued by the County of Otero.


TERMS OF PAYMENT:

All bills rendered under this rate are due and payable within twenty (20) calendar days of the date of rendition of the bill and are subject to rules and regulations as set forth in NMPRC Rule No. 960.

TERMS AND CONDITIONS:
