APPLICABILITY:

Applicable to all metered service. Service will be furnished in accordance with the Company's General Rules, terms and conditions available at the Company's office and on file with the New Mexico Public Regulation Commission, which General Rules or subsequent revisions thereof are a part of this schedule as is fully written herein.

TERRITORY:

Indian Hills, Woodland Hills and Squaw Valley Subdivisions and Adjacent Territory.

RATES:

Connection Charge:

The company is authorized to charge a new service connection charge of

\$1,000.00

for the purpose of connecting any adjacent distribution systems to the customers' premises which do not have an existing service or meter.

Water Rights Fee:

The company is authorized to charge a Water Rights Fee of

\$1,200.00

for the connection of new service which applies only to new service construction and does not apply to premises with an existing service or meter.

Collection Charge:

If the customer does not pay for water service within 35 days of bill rendition, and at least two (2) days after notice is given in compliance with Company rules, the company may make a collection charge of up to

\$5.00

in the event it is necessary for the company to make collection of said bill away from the company's established office.

Disconnect Meter Fee: (At customer's request)

If the water service is voluntarily discontinued at the customer's (or agent thereof) request the company is authorized to charge a Disconnect Meter Fee of up to

\$20.00

to cover the cost of disconnecting service.



Reconnect Charge:

Whenever service is discontinued for nonpayment of charges, nonuse or similar reasons in the course of normal business a charge of

\$15.00

may be made by the company to cover the cost of reconnecting service when it is again requested.

Meter Testing Fee:

The company is authorized to charge a Meter Testing Fee of

\$15.00

under the following conditions: Upon request by a customer, the company shall make a test of the meter serving him/her that he/she may be present. If the meter has been tested within the last twelve (12) months, the company may charge the customer a meter test charge for making such a test. Such charge will be refunded to the customer if the meter proves to be in excess of two percent (2%) fast. Such charge will be refunded to the customer whenever the meter proves to be in excess of 2% fast.

Late Fee:

The company is authorized to assess a late fee on the past due amount of:

.67%/Monthly

This fee will be assessed by the company on the past due/delinquent portion of bill for monthly rates and usage.

Credit/Debit Card Transaction Fees:

If a customer requests to make payment by credit or debit card, the applicable transaction fee charged by the credit/debit card will be added to the payment at the time of payment.


