

## State Fire Marshal's Office, NMPRC Announce 2015 **International Fire Code Adoption Public Hearings**

SANTA FE - In the weeks ahead, the New Mexico Public Regulation Commission and the State Fire Marshal's Office will conduct public hearings throughout the state prior to amending certain rules pertaining to the State Fire Marshal, including repealing and replacing the 2003 International Fire Code with the 2015 International Fire Code.

The New Mexico Public Regulation Commission will host the 2015 International Fire Code Adoption public hearings throughout the state in February and March at the following locations and dates:

- Friday, March 3, 2017, 10:30 a.m., Public Regulation Commission's 4th Floor Hearing Room, 1120 Paseo de Peralta, Santa Fe, NM
- Monday, March 6, 2017, 10:00 a.m., Rio Rancho Fire & Rescue Administration Training Room, 1526 Stephanie Rd. SE, Rio Rancho, NM
- Thursday, March 9, 2017, 10:00 a.m., Roswell Fire Department Station 3, 2800 N. Wilshire Blvd., Roswell, NM
- Friday, March 10, 2017, 2:00 p.m., The Branigan Memorial Library (DRESP A), 200 E. Picacho, Las Cruces. NM
- Monday, March 13, 2017, 11:00 a.m., Farmington Civic Center, 200 W. Arrington St., Farmington NM

The Commission issued an Order establishing the rulemaking docket and issuing the notice of proposed rulemaking on December 21, 2016, and distributed the Order to fire departments throughout the state via email and first-class mail. The Order has also been on the cover page of the NMPRC's web site

The deadline for written comments pertaining to the proposed rule revisions was Tuesday, February 14, 2017, and the deadline for written response comments is Tuesday, February 28, 2017.
